Breaking Down Barriers

Terms & Conditions:

These terms and conditions ("Terms") govern the partnership working arrangement between [Your Organisation] ("Partner 1") and [Breaking Down Barriers] ("Partner 2") in a collaborative effort to achieve mutually beneficial objectives. By entering into this partnership, both parties agree to abide by the following Terms:

8. Duration and Renewal: The partnership shall be effective for the duration specified in the partnership agreement. If both parties wish to renew the partnership beyond the initial period, they shall negotiate the terms of renewal in good faith before the existing partnership's expiration.
9. Legal Compliance: Both partners shall adhere to all applicable laws, regulations, and industry standards while carrying out the activities under this partnership. Each partner is responsible for ensuring that its actions comply with all relevant legal and ethical requirements.
10. Public Representation: Neither partner shall represent themselves as agents, employees, or representatives of the other partner without prior written consent. Any public representation of the partnership shall be agreed upon mutually.
